	 This event was a good start but it was suggested more effective time should have been made to understand and deal with the blockers to developing off- site water.

4.2	Client Product Group Meetings	
	JB/JR updated the group on the meeting held on 24 th May (Mins to follow). Advised that:	
	 Amy Ladyman had given an good presentation of the Water Company Standards spreadsheet. JR Agreed to send out the spreadsheet to the group. 	JR
	 Common Language: The meeting had agreed to adopt best practice and naming conventions from the water companies. JR to send this out to the wider Water Group for comments, noting this is WIP. 	JR
	JR to agree the notes from this meeting, which will then be distributed.	JR
	There was a discussion around the structure and governance of these meetings:	
	JR emphasised the goal to work collaboratively as client/consultant/supply chain/contractor groups but thought that clients also needed a separate forum to discuss sensitive items.	
	Actions on products - common proposals document required for Standard Products. JR to follow up with SW offline.	JR/SW
	There was a discussion around the need for 2 groups and whether Clients could be part of both Hub and client groups.	
	JR advised Water Hub group now consists of BoS members and guests (non-members). JB sees this as a positive element – it is making progress in getting all water companies to the table.	
	There was a discussion around the need for Water Consultancies such as Atkins, MWH, Arup to be included as they could be a pinch point in off-site.	
	Group supportive of a client group meeting followed by 2nd, broader Water Hub meeting or possibly projects with representation from client, consultant, contractors supply chain.	
	JR to draft a governance proposal and send to Leads Group by 14/06/17.	JR
	There was a discussion around developing a suite of products along investment streams for water e.g. NEP, 'P removal' programme, SEMD Equipment and the need work together to create a solution for common programmes relevant to most water companies.
